The Board of Directors received the May financial reports. Chief Schneider reviewed the financial report with the Board of Directors. The quarterly tax revenue received from Clackamas County was included in the Board packet.

The 2023/2024 Budget was submitted to the Budget Committee with no changes. The Board of Directors received the 2023/2024 budget and had the opportunity to ask questions.

Heather Goodrich, Chief of Health and Safety. Division Chief Doug Whiteley, Community and Administrative Services Division. Division Chief Dan Mulick, in charge of Operations. Shawn Olsen oversees the Fire Marshal Office. Ryan Kragero, Volunteer Coordinator and Battalion Chief Melanie Kinne.

Oversight Committee

This committee is made up of two Sandy Board members, two Clackamas Board members and Fire Chief Nick Browne. The Board Chair appointed Ron Lesowski and Ryan Fox to represent the Sandy Board of Directors on the Oversight Committee.

Volunteer Statement

Chair Sue Hein read a statement on behalf of the Sandy Fire District Board of Directors stating that due to the signed Intergovernmental Agreement with Clackamas Fire District, "The Sandy Volunteer Firefighter's Association will no longer be recognized or affiliated with Sandy Fire District beginning July 1, 2023." A question was asked "what does this statement mean." Sandy Fire District, served by Clackamas Fire, will only have one affiliated non-profit organization. Clackamas Fire District uses the Clackamas County Emergency Services Foundation. Access to buildings/facilities would only be for current Clackamas Members only.

Volunteer Board member Rayner Yoshioka attended the meeting but had no report.

Director Fox thanked the volunteer organization for their time and dedication they have given over the years.

<u>Clackamas Fire Report</u>

Chief Deters reported that it has been busy working to get everything up and running for July 1st. There is a lot of movement behind the scenes. We are working with the IT department on ESO calls, archiving and onboarding. Fleet is working on getting equipment changed over to be in line with Clackamas Apparatus. Unfortunately, even though equipment has been ordered there is a lag. We are still working on the phone system and what that looks like. The burn number will change but the recording will have the information for people to call going forward. Lastly, we are planning on having office staff in the building Monday – Thursday 7am – 5 pm with office hours being 8:00am- 4:00pm and Fridays by appointment. The Fire Marshals office will be at least 3 days a week and by appointment.

Director Brian asked if there have been any unanticipated challenges. Chief Deters commented that the Sonitral system for the access to the building has been an unanticipated challenge. Making sure everyone has access before and after July 1st.

Chief Browne discussed the Forest Park Wildfire that is currently going on in Clackamas County. We have set up a unified command with the Oregon Department of Forestry. We have Crew 30 working, and a helicopter was called in last night. There was a Level 2 evacuation ordered but has since been cancelled. Crews stopped forward advancement. ODF will be taking over and working on a grid system to locate and extinguish hot spots. Chief Browne reported there is a wildfire located near Timothy Lake. Clackamas has a Chief in the area assessing the situation with fire officials. This can be concerning for the start of fire season as we are still in June, and it is pretty dry. Chief Browne commented that we are far more prepared than we were in 2020.

There will be a swearing-in ceremony on June 28, 2023, at Camp Withycombe beginning at 5:00 pm. We will be swearing in all Sandy Fire personnel along with Clackamas Fire promotions and new hires. Chief Browne personally invited the Board of Directors to attend.

Fire Chief's Report

OSFM Wildland Staffing Grant

Sandy Fire was successful in receiving the OSFM Wildland Staffing Grant. This is \$35,000 to aid in upstaffing during red flag days.

Director Brian asked if Sandy Fire applied for the Safer Grant. Sandy Fire did not apply for the staffing grant but if the Board of Directors wanted to pursue that in the future, we should discuss in further during a Board Work Session.

ISO Update

Chief Schneider was informed that Sandy fire will stay at a 3/10 for our ISO rating. We were 5 points aways from a 2/10. Chief Schneider will be reviewing the information to see where we need to improve for the next time.

Clackamas County Fire Defense Board

The Clackamas County Fire Defense Board, made up of Clackamas County Fire Chief's, announced this week they will close residential, backyard, and agricultural burning early due to weather conditions. Recreational fires/warming fires will still be allowed.

Outreach Events

Chief Schneider attended a wildfire safety fair at Timberline. There were 15 agencies that attended and roughly 233 people went through the event.

Chief Schneider also attended a wildfire safety fair with PGE at Sandy High School. This event was also well attended by residents.

Chief Schneider discussed with the Board of Directors the City of Sandy water treatment plant and the moratorium. Chief Schneider has met the new director and they have some long-term goals for the water based on the growth. It was discussed to see if the director could meet the board at an upcoming meeting. Chief Schneider will reach out to the City of Sandy to schedule.

Board Chair Sue Hein called the Special Board Meeting to order at 8:07 am.

Attendance: Board Chair Sue Hein, Board of Directors: Andrew Brian, Mark Maunder, and Ron Lesowski. Sandy Staff: Fire Chief Phil Schneider, Division Chief Jason McKinnon, Office Manager Nannette Howland, and Bookkeeper Rachel Frentress. Clackamas Staff: Chief Financial Officer Mark Whitaker.

Director Ryan Fox was not in attendance.

Financial Update

The Board of Directors received the projection of year-end Personnel Services expenses. The Board was unsure how we ended up with the projected numbers being over when the last Board financials showed tracking with the benchmark. Chief Schneider reported the board financials for last month didn't include a staff overtime payroll and the associated rollups. Although Chief Schneider has cancelled some overtime costs (training & water rescue), the overtime costs for May and June were a lot higher than projected due to staff injuries and required minimum staffing coverage. Overall, overtime cost and associated rollups year to date was over budget. Vacation and comp payout costs and volunteer final reimbursement are within the \$200,000 Personnel Services CD.

The Board of Directors asked Chief Financial Officer Mark Whitaker if using contingency will cause any problems with the next fiscal budget. This shouldn't be an issue. The Board of Directors may see a decrease in the budget amount for cash carryover in the audit.

The Board of Directors received a resolution to transfer funds from Contingency to Personnel Services.





Incumbents lead in contested Sandy Fire Board races

Early results are in for two contested Sandy Fire board races.

With few contested races occurring locally in Sandy, attention was drawn to two races for the Sandy Fire District board during the May 2023 Special District Election.

After early returns came in at 8 p.m. Tuesday, May 16, incumbent Andrew Brian held a lead with 80.26% of votes for Position No. 1 on the Sandy Fire District's Board of Directors. Trailing was Jeremy L. Parker with 19.35%. The position is a four-year term.

For Position No. 4, incumbent Ryan C. Fox led the pack of the three contenders with 73.67% of votes. Nick Walden Poublon followed in second place with 16.06% and Rayner Yoshioka held 9.88% of the votes. This position is a two-year term.

According to the Secretary of State's Office, 21.43% of votes have been reported thus far.

Two longtime Sandy Fire board members retained their positions uncontested — Sue Hein in Position No. 2 and Ron Lesowski in Position No. 3. Both positions are four-year terms.

Chairperson of the board Hein has served with the group since 2015, and Lesowski, who acts as secretary and treasurer, was voted in in 2018.

Brian is a director on the board and has participated in this capacity since 2013. He also is a firefighter for Sandy Fire District.

"Early results are promising, but I don't want to count my chickens," Brian said when asked for comment.

Brian's opponent, Jeremy L. Parker, served on the volunteer board previously for 10 years and has served as a volunteer firefighter for 14 years. Professionally, Parker is a business owner, operating Oregon Induction Corp and Oregon Metallurgy.

"I've learned a lot from this experience," Parker said, already congratulating Brian for an apparent win. Parker added that he may run again in the future, but for now was "taking a step back."

Fox was appointed on March 9 to fill the Position No. 4 seat on an interim basis when the spot was vacated by former director Justin Stuchlik. His term is set to end June 30 unless he is chosen by the voters.

Sandy, neighboring cities sign mutual aid agreement

Clackamas County, Estacada, Happy Valley, Lake Oswego among partnering agencies

On May 15, Sandy City Council authorized City Manager Jordan Wheeler to sign an intergovernmental agreement (IGA) that will allow cities to lend personnel to partnering municipalities within Clackamas County when employees are unable to get to their own places of work due to emergencies.

"A vulnerability that affects our ability to respond to an emergency will be the availability of employees, their location, and capabilities to respond," Wheeler explained in his staff report. "In the event of a significant disaster, transportation routes may be damaged or disruptive leaving employees stranded and unable to report to their normal work location.

However, these stranded workers may be able to assist with the emergency response and operations of another public agency within Clackamas County. Since many of the skills and duties of public personnel are transferable and emergency operations plans follow the same structures and procedures, stranded workers can easily be assigned to another agency's emergency response needs."

Wheeler added that this agreement is similar to the mutual aid agreements public safety departments already have in place, like that between Sandy Fire

District and neighboring fire districts. The stranded personnel IGA was created using those similar agreements as a reference.

Several city attorneys, Clackamas County Counsel and City/County Insurance Services have reviewed the agreement. Many agencies in Clackamas County have already signed on to participate, including the cities of Estacada, Happy Valley, Tualatin, Wilsonville, Molalla, Lake Oswego, Milwaukie, as well as Oak Grove Sanitation District and Clackamas County.

All cities and special districts within Clackamas County are eligible to sign the IGA voluntarily.

According to Wheeler's report, "there is no budgetary impact for

adopting the IGA since the city would recover any costs associated with the lending of personnel."

"Cities that lend personnel to a borrowing agency can invoice the borrower for the total cost of providing the employees as well as any overhead costs," he wrote. "Participants have the ability to choose whether to allow their personnel to participate during the emergency situations."

"Hopefully, we never have to use (this IGA)," said Deputy City Manager Tyler Deems. However, Deems added that since "Sandy is a bit of an island," it is good to have formal agreements like these in place in the event of a natural disaster like the Riverside Fire of 2020.

Sandy Mountain Festival Parade Celebrates city, fire crews as grand marshal's

In years past, the honor of grand marshal of the Sandy Mountain Festival parade has always gone to a community member or members who have exemplify service.

In 2019, the Gerens, farm supply owners and volunteers, were honored and in 2022 when the festival returned after a pandemic-related hiatus, Shannon and Martin Montgomery, longtime festival organizers shared the title.

This year, the honor has been bestowed upon a team of people Sandy residents interact with regularly and who work every day to ensure the city is functioning: the Sandy and Clackamas Fire Departments and the City of Sandy.

"I'm proud that the Sandy Mountain Festival has decided to honor our local city government in this way," Mayor Stan Pulliam said. "We have been proud partners to the festival for many years. I know our team members that work tirelessly for the betterment of our community are excited to be recognized." Festival board president Valerie Gillum said she wanted to honor those who have worked for years to help make the festival successful, but also welcome the transitions happening within Sandy.

As of July 1, Sandy Fire Chief Phil Schneider is retiring as chief, and Clackamas Fire begins it's operational contract with Sandy at the same time, granting Clackamas Fire Chief Nick Browne oversight of the Sandy district. May 31, former city manager Jordan Wheeler left his position and Interim City Manager Tyler Deems has stepped in while the city seeks candidates. Later this year, Sandy Police Chief Ernie Roberts will also leave the department for retirement, and his successor has yet to be announced.

Lt. Sean Lundry with the Sandy Police Department said he's "enjoyed the collaboration with the Sandy Mountain Festival committee" over the eight years he's been at SPD.

Sandy Police ensure there are extra officers on duty for the festival weekend, and they help block off streets and keep watch during the parade as well.

"I think it's really neat to be involved with those citizens; they donate countless, hundreds of hours to put this on for our community, and I think it's a really special event," Lundry added. "I also enjoy seeing community come out and enjoy the event, and you kind of get a front row seat to that because you're standing right there on the corner. You get to interact with the kiddos and give them candy, and just see everyone enjoying themselves."

With the operational contract Sandy Fire has signed with Clackamas Fire, as of July 1 the Sandy district will receive even more aid from Clackamas to respond to the demand of the growing community. The two departments plan to showcase their partnership with their presence in the parade.

Chiefs Schneider and Browne will ride in the festival parade on July 6 in a 1940s-era fire engine, followed by others from their crews in engines that now read "Clackamas Fire serving Sandy." "I'm pretty excited," Schneider said of the opportunity to serve as grand marshals. "It's not about me, but it's (honoring) the whole fire district, and everything we've done over the last 100-plus years. I thought that it was cool that (the festival) thought it would be important to recognize us. I feel really blessed."

"For me, it's a complete honor that the community would do this," Browne said. "I think it's phenomenal for me to be able to sit side by side with the legend of a fire chief that Phil Schneider is; it's humbling. And it truly is an honor. Phil has dedicated himself to the citizens of Sandy for 47 years, and if you really think about that and the amount of life he's dedicated to service. To be able to be side by side with him and be in that parade together, I think it represents what the fire service is about. The fire service is about uniting, about becoming a team. It's about joining together to do the best thing for the taxpayer, and I just love what that represents." The plan going forward is a full-functional agreement, and it will involve Clackamas providing a three-person 24/7 engine company and a two-person peak unit for 12 hours a day for seven days a week.

Currently, Sandy Fire operates with a four-person crew 35% of the time and a three-person company 65% of the time. With the contract, they'll gain two people per 12-hour period (during the peak call time).

Schneider plans to stay on for six months as a division chief to aid in the transition, then officially retire in the beginning of 2024.

"I feel very good about (this contract)," Schneider said. "I feel that Sandy is going to be in very good hands."

Browne said he's excited that the festival is so soon after Clackamas Fire's contract begins, and he's looking forward to "that opportunity to introduce ourselves and be able to start to show and earn that respect and trust from the citizens."

"We want to let them know that we are here, we are your fire department, we are excited about the opportunity to be your fire department and we are looking forward to being able to serve you," he added. "What firefighters love outside of responding to needs of the community on 911 calls is getting to know their community and to be a part of their community. And Clackamas Fire is no different."
