#### R-1a Office of the Fire Chief – Fire Chief Nick Browne

Chief Browne reported that the district has been busy with significant fires over the last month. He mentioned the Sandy event, Trick or Treat Trail, on October 28 from 2-4 p.m. He reported on a life-saving award that was awarded to a citizen. This award program was adopted from the Sandy Police Department's Kindness Award program. He said a fourth grader from Sandy Elementary School was awarded the kindness award.

**Subject** Contract for Service Transition Costs

#### **Action Requested**

Staff requests Sandy Fire District #72 Board of Directors approve one-time transition costs to be paid to Clackamas Fire District in the amount of \$41,932.

#### **Background**

Under the contract for service, Sandy Fire agreed to reimburse Clackamas Fire for certain costs related to onboarding previous Sandy Fire employees and outfitting Sandy apparatus and stations. As noted on the next page, many transition costs related to employee leave balances and medical exams have already been paid.

The remaining costs are mainly for materials, including uniforms and clothing for new employees (or repatching of existing uniform and gear); labeling of apparatus; communication and mobile computing equipment for apparatus; station fitness equipment; nozzles, couplings, and medications; and various station supplies. An unanticipated facility expense was the cost of repairs to Sandy's HVAC system, which broke just before July 1<sup>st</sup>.

In total, the costs represent 90 separate purchases from vendors and 32 pick tickets (orders taken from Clackamas Fire's existing Logistics and Fleet inventory) totaling \$87,920. After applying the turnout and apparatus equipment credits approved by the Board of Directors in September plus a new credit for postage stamps, the total remaining cost to Sandy Fire is \$41,932.

#### **Board Policy Implications**

The original estimate for total transition costs was \$488,975, but total transition costs ended up totaling \$342,500 after credits.

These transition costs were presented to the interagency committee on October 31, 2023. The committee recommended bringing the costs to the full Board of Directors for approval.

#### **Recommendation**

Staff recommends the Sandy Fire District #72 Board of Directors approve one-time transition costs to be paid to Clackamas Fire District in the amount of \$41,932.

# FIRE CHIEF'S REPORT

#### OCTOBER 2023

## Highlights

- The new cardiac monitor equipment funded by a \$1M FEMA AFG grant has arrived. After initial checks and programing, it will be distributed district wide.
- A State Homeland Security Program grant was awarded to Clackamas Fire in the amount of \$60,000 for enhanced multi-casualty simulation training equipment. This will provide valuable improvements to our training delivery next year.
- Volunteer Academy 23-02 started with 15 volunteers.
- The District was not successful in obtaining an AFG grant for radio purchases. Staff is working to extend portable radio and battery life to buy some time to research new radio options to budgeted for.

## **Notable Events/Calls**

10/01/23	Crews responded to a fire at an old car lot on McLoughlin Blvd and identified a vehicle fire in an attached garage of the single-story commercial building. The fire, which self-vented in the garage, had extended to multiple other vehicles and shrubs across the Charlie, Delta, and Alpha sides. Crews worked quickly to mitigate the incident. No further extension occurred and no reported injuries.
	further extension occurred and no reported injuries.

SE 20th Ave. Crews arrived to a duplex fire with an involved fire on the Delta side of the structure and extension into the attic. Crews quickly confined the fire. The resident was evaluated by crews and found to have no injuries.

10/08/23 Fishers Mill Rd. The South Battalion responded to a 40x60 shop that was 90% involved upon arrival. Crews were in the defensive strategy due to heavy fire involvement. Crews found a living quarters in the building but everyone was out safely.

10/11/23 Bristol Park Dr. The North Battalion responded to a fire in a single family home. Upon arrival, crews located a fire on the Charlie side with extension into the attic. The fire was quickly brought under control with no injuries.



# CLACKAMAS EMERGENCY SERVICES FOUNDATION BENEFIT AUCTION ON NOV. 4

Clackamas Emergency Services Foundation is holding their 10th annual Dinner and Auction fundraiser on November 4, 2023 at Gray Gables Estate in Milwaukie, Ore. The money raised at the fundraiser goes to those who have experienced a fire, accident or other tragedy. Foundation funds can provide short-term disaster relief such as a warm hotel room in the middle of the night, a change of clothes, transportation or necessary toiletries and food until other social services agencies can step in.

"The Automated External Defibrillator (AED) reimbursement program through CESF has allowed more places to have an AED, than would normally be able to have one in the past. Being able to place these machines in places like schools, fitness centers, and churches allows the county to have more public access to AEDs which means we have more people saved after a cardiac arrest episode (or what we call a cardiac arrest save) because of the quick access to these machines," says Bill Conway, Public Health Emergency Services Manager, Clackamas County Public Health Division, Department of Health, Housing & Human Services.

Some of the community programs the Foundation fundraiser supports are:

- Providing smoke alarms and kids' bicycle helmets
- Placing automatic external defibrillators (AEDs) in the community over 400 have been placed to date!
- Scholarships for college students studying emergency services professions
- Operation Santa Claus providing toys and food for families in need
- Food programs like Feed the Hungry, Inc.
- Community non-profits like Mt. Hood Search & Rescue Council and Backpack Buddies (providing food insecure students with meals on weekends and holidays)
- Grants to help individuals access woodchippers for home wildfire mitigation efforts

The Foundation is seeking sponsorships and donations for their live and silent auctions at the event. Sun Glow Home Services is our Gold Sponsor and we appreciate their support. The community is invited to attend the event to help raise funds to support our friends and neighbors in the Clackamas County community.

# CLACKAMAS FIREFIGHTERS EXTRICATE PATIENT ON HWY 26 SUNDAY AFTERNOON (PHOTO)

At approximately 4:30pm on Sunday afternoon, Clackamas Firefighters responded to an injury accident involving two vehicles, one mile east of Shorty's Corner just outside Sandy at mile post 27. On arrival, Clackamas firefighters reported one patient trapped in a vehicle with heavy impact and another patient standing on the side of the road with minor injuries. Due to the recent contract for service with Sandy Fire, Clackamas Fire firefighters were able to respond out of the Sandy Fire Station with two apparatus and were on scene within minutes to provide extrication and medical care to the two patients. Life Flight Network helicopter was launched immediately to provide the quickest transport to an area trauma center. Oregon Dept. Of Transportation (ODOT), Oregon State Police (OSP) and Clackamas County Sheriff's Office (CCSO) were also on scene to provide traffic control and investigate the accident.

Clackamas firefighters from Damascus and Clackamas with specialized training and heavy extrication equipment also responded to assist Sandy crews on scene. Once extricated, the patient was treated and transported by Clackamas Fire and American Medical Response (AMR) paramedics to the landing zone where patient care was transferred to Life Flight. Crews remained on scene briefly to clean up debris and ensure vehicles did not pose any danger.
