Action Requested

We request the Board of Directors approve payment of \$40,043 to Clackamas Fire as reimbursement for consulting and capital outlay expenses paid by Clackamas Fire in FY 2024-25 on Sandy Fire District's behalf.

Background

The majority of Sandy Fire's expenses in its FY 2024-25 budget are for its contract for service with Clackamas Fire. However, Sandy Fire also budgeted for a few additional expenses: \$25,000 in professional fees to contract with a public relations consultant and \$25,000 in capital replacement for tap out installation at Station 74 and exercise equipment at Station 74.

Sandy Fire ultimately chose Coastline as the vendor for public relations, and Clackamas Fire has been paying those invoices on Sandy's behalf at \$2900 per month. By year end, the expected expense is \$20,300.

Clackamas Fire also completed the work at Station 74, totaling \$3,550 for the tap out installation and \$9,493 for the exercise equipment. In addition to those expenses, Clackamas Fire has completed two other capital purchases for Sandy Fire this fiscal year: replacing the motors on one of the bay doors at Station 71 (\$5,000; the original motors were not equipped for the frequency at which the doors are used with R371) and bringing Station 74's natural gas line up to code compliance (\$1,700).

Budget Implications

The proposed reimbursements are within Sandy Fire's budgeted amounts for FY 2024-25:

Staff Recommendation

Highlights

- Skylar Delaunay, a 7th grader at Gardner Middle School in Oregon City, was presented with a *Citizen Life Saving Award* for saving his older brother's life.
- Clackamas Fire attended the Sandy Area Chamber of Commerce *The Bite* and presented an overview of emergency response efforts in Sandy.
- The Beavercreek Station will be accepting yard debris free of charge on May 10 and June 8. This event is offered to homeowners in the District to help reduce risk around their homes from wildfires.
- Clackamas Fire is conducting wildland urban interface exercises with Clackamas County. These tabletop exercises are centered around a simulated emerging fire and are designed to provide realistic experience to incident commanders, the County Emergency Operations Center, and the Public Information Officers from cooperating agencies.
- With levy funds, a 24/7 staffed fire station, located in rural Oregon City's Logan area, is scheduled to open July 1, 2025.
- Annexation talks with Gladstone City Council and Sandy Fire District's Board of Directors continue for a possible annexation with both cities. If approved, voters will be able to cast their ballots in November 2025. Open houses have been scheduled for the public to ask questions about the annexations.


April 12 – Technical Rescue at Willamette Falls


Reports were received at approximately 11 p.m. that a person in a kayak had gone over the Willamette Falls. This incident involved collaboration with numerous agencies, including Clackamas County Sheriff's Office, Oregon City PD, West Linn PD, Canby Fire, Lake Oswego Fire, Tualatin Valley Fire & Rescue, Portland Air Ops, and the US Coast Guard, and was widely covered by the media. Access was a challenge, and drones were utilized in the search. After an extended search, the victim was not located and presumed drowned. The body was later located and recovered on May 4, just North of Meldrum Bar Park.


